(for the students in **the second and third year** of study – **bachelor** programme and also for the srudents in the **second year** of study – **master** programme, that will not manage to finish their internship until the last scheduled evaluation of the second semester)

As a result of the discussions of the Board of directors of BUES, from the 26th of May 2021, regarding the *approval of the request of the BUES Students Union on extending the deadline for the internship until August 26, 2021*, we inform you (subject to the approval of the request of student representatives by the BUES Senate) about the following:

who will not be able to complete the internship until the date related to the scheduling of the colloquium in the REPROGRAMMING session of the second semester MUST:

- 1. Students who did not applied for an extension of the internship completion period and do not participate in the internship colloquium in the evaluation session for the second semester, respectively in the rescheduling session, will not be able to hold the colloquium in the August September 2021 special session.
